# **OUR SUPPORT PROCESS**



As part of the Race Equality Environmental Programme, CEMVO offers a bespoke consultancy programme tailormade to each environmental organisation seeking support. Following an initial meeting and upon signing the client agreement, CEMVO will support the individual organisation to identify key action points that require improvement to further progress race equality.

For example, data collection and analysis, recruitment and training, or organisational culture etc. Meetings will take place following this to monitor progress and provide further guidance and support where needed. Post-consultancy support, an evaluation will be conducted to measure impact on race equality within the organisation.

# ENVIRONMENTAL RACE EQUALITY TRAINING AND INTERACTIVE WORKSHOPS
